The undersigned William H. Abbott your Petitioner, respectfully
represents that he is an alien, a native of Canada that
he arrived in the United States a minor, under the age of twenty-one years; that he has resided in the United
States three years next preceding his arriving at that age; that he has continued to reside therein to the time
of his making this, his application to be admitted a citizen thereof; that he has now arrived at the age of
twenty-one years; that he has resided in the United States five years and upward, to-wit: for the term of
thirty years, including the three years of his minority, and in the State of Illinois for one
year immediately preceding this application; that it is bona fide his intention to become a citizen of the United
States, and to renounce forever all allegiance and fidelity to every foreign Prince, Potentate, State or Sovereignty
whatever, and particularly to King of Great Britain & Canada whereof
he was heretofore a citizen or subject, and for two years next preceding it has been bona fide his intention to become a
citizen of the United States. And further, that he has never borne any hereditary title or been of any of the degrees
of nobility of the country whereof he has been a subject. And he further states that he does not disbelieve in and he
is not a member of any organization with, any organization entertaining or
any person in violation of the Contract Labor
of the United States; nor has he violated any provision of an Act of Congress, entitled "An Act to regulate the immigration
of aliens into the United States," approved March 3, 1903. Your petitioner, therefore, prays that he may be
admitted to become A NATURALIZED CITIZEN OF THE UNITED STATES OF AMERICA, pursuant to the
several Acts of Congress heretofore passed on that subject.
